WAITING RESTRICTIONS

London Borough of Camden

Notice is hereby given that the Greater London Council are about to consider a proposal that they should make an Order under section 6 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which would be in the London Borough of Camden, to impose restrictions on waiting by vehicles between 8 a.m. and 12 midnight throughout the week in:

Pond Street the south-east side.

South End Road

(a) the north-east side, between the south-western kerb-line of the south-western arm of South End Green and the north-western kerb-line of Pond Street;

(b) the south-west side, between a point opposite the party wall of Nos. 9 and 11 South End Road and the north-western kerb-line of Pond Street.

Any existing restrictions similarly imposed on waiting by vehicles in the above-mentioned lengths of streets would be revoked.

Exemptions would be provided in the Order to permit vehicles to wait in order to pick up and set down passengers, to load and unload goods for limited periods, to carry out essential services or when used by local authorities in pursuance of statutory powers or duties.

Any representations regarding the proposal should be sent to the Traffic Commissioner and Director of Development, The County Hall, London S.E.1, by 31st July 1970, quoting the reference PT/TD/LS.
