# Queen's Road area controlled parking zone 'QR'

The London Borough of Southwark (Charged-for parking places) (CPZ 'QR') Order 202\*
The London Borough of Southwark (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (CPZ 'QR' and surrounding area) Order 202\*

1. Southwark Council hereby GIVES NOTICE that it proposes to make the above orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

- 2. The general effect of the orders, as part of the provision of the new controlled parking zone 'QR' in the Queen's Road area would be:-
- (a) to provide permit holders' parking places, in which vehicles in respect of which have been granted either a valid residents' permit, a valid business permit or a valid visitors' permit may be left between the hours of 1 pm and 3 pm on Monday to Friday inclusive, in:- BURCHELL ROAD, CARLTON GROVE, KING'S GROVE, MONTPELIER ROAD, and WOOD'S ROAD;
- (b) to provide 'shared-use' parking places in which either:- (i) vehicles which have paid the parking charge of £5.10 per hour/£8.30 per hour for diesel vehicles (using 'Pay by Phone') may be left for up to 1 hour (provided no vehicle may return to a parking place on that same day), or (ii) vehicles in respect of which have been granted either a valid residents' permit, a valid business permit or a valid visitors' permit may be left without time limit, between the hours of 1 pm and 3 pm on Monday to Friday inclusive, in:- BURCHELL ROAD, CARLTON GROVE, KING'S GROVE, MONTPELIER ROAD, and WOOD'S ROAD;
- (c) to introduce 'timed' waiting restrictions (single yellow lines 'SYLs') operating between the hours of 1 pm and 3 pm on Monday to Friday inclusive in WOOD'S ROAD covering the full length at each location of existing School Keep Clear markings in the vicinity of John Donne Primary School (a total of 121 metres);
- (d) to introduce 'at any time' waiting restrictions (double yellow lines 'DYLs') at road junctions, footway and vehicle crossovers, and between kerbside designated as parking places in the above-mentioned streets (in so much as is public highway), apart from where there are existing School Keep Clear markings. Loading or unloading to or from attended vehicles would be permitted for a maximum of 40 minutes at any single location on DYLs;
- (e) the Council will take the opportunity to increase existing DYLs in the roads outside the new CPZ 'QR' in the surrounding area in: (i) ASYLUM ROAD east side add 1.5 metres north-west of its junction with Staveley Close and 2.5 metres north of its junction with Station Passage, (ii) HOLLYDALE ROAD north-east side add 13.5 metres o/s Nos. 2 and 4 Hollydale Road and south-west side add 4 metres south of its junction with Lugard Road, and (iii) LUGARD ROAD south-east side add 2.5 metres o/s No. 11 Lugard Road; and
- (f) the Council will take the opportunity, to more closely reflect what is in the street by formally amending the Traffic Management Orders to match what is in the street, to: (i) remove an existing 'doctor only' parking place in WOOD'S ROAD which is no longer needed, (ii) add an existing disabled persons' parking place 6.6 metres in length in WOOD'S ROAD south-west side o/s No. 24 Wood's Road, (iii) relocate an existing cycle hangar in KING'S GROVE from the carriageway east side opposite No. 99 King's Grove to a location on the footway opposite No. 101 King's Grove, and (iv) add 6.5 metres existing DYLs in KING'S GROVE o/s No. 97 King's Grove.
  - Existing disabled persons' parking places in the above streets and the trial 'e-scooter & cycle hire' bay located in Burchell Road would not be affected by the proposals. Note that all measurements listed are in metres and are approximate.
- 3. Residents' permits, business permits and visitors' permits would be available to residents and businesses located at qualifying addresses located within the parking zone boundary, which are not subject to a planning agreement restricting the grant of permits.

# Statement of reasons



## Queen's Road area controlled parking zone 'QR'

The London Borough of Southwark (Charged-for parking places) (CPZ 'QR') Order 202\*
The London Borough of Southwark (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (CPZ 'QR' and surrounding area) Order 202\*

Following the informal consultation stage on the proposal to implement a new controlled parking zone (CPZ) in the Queen's Road area, the <u>Cabinet Member for the Climate Emergency, Clean Air</u> and <u>Streets</u> approved the following recommendation, in March 2024;-

To implement the new CPZ 'QR' in the eastern part of the London Borough of Southwark, within the Nunhead & Queen's Road ward.

The zone operating hours will be Monday to Friday 1 pm to 3 pm.

Based on the feedback to the informal consultation, and our obligations under the Road Traffic Regulation Act, the council are proposing to implement a revised smaller controlled parking zone in the Queens Road Area that operates Monday to Friday, 1 pm to 3 pm.

Based on the road-by-road analysis per road from the informal consultation, Montpelier Road wanted parking controls on their road. However, if a CPZ were to be implemented in just one road, there would be displacement on to King's Grove and Carlton Grove. In addition, respondents from King's Grove would support the implementation of a controlled parking zone if implemented on a nearby road. Therefore, putting in King's Grove and Montpelier Road only would likely result in significant displacement onto Carlton Grove; thus it is proposed Carlton Grove is included in the proposed revised design.

Similarly, Cossall Walk support controls on their road, and Wood's Road support controls if a neighbouring road is included. Thus, Burchell Road has also been included in the proposed new design based on officer recommendation that displaced parking will likely be significant on Burchell Road if controls are not implemented.

This will help ease parking pressure in the roads, which show high levels of parking stress and the roads; which will be impacted by the displacement, should a permit scheme be implemented on the roads which support permit controls.

The proposed zone takes into consideration roads where residents were not in support of controls and can be feasibly excluded from the new proposed area. Asylum Road, which is not included in the new zone, will be the boundary road between the permit area and uncontrolled area.

Proposed parking within CPZ 'QR' will be:-

- 1) **permit holders' parking places** in which vehicles in respect of which have been granted either a valid residents' permit, a valid business permit or a valid visitors' permit may be left between the hours of 1 pm and 3 pm on Mon-Fri inclusive; and
- 'shared-use' parking places in which either (i) vehicles which have paid the parking charge of £5.10 per hour/£8.30 per hour for diesel vehicles (using 'Pay by Phone') may be left for up to 1 hour (provided no vehicle may return to a parking place on that same day), or (ii) vehicles in respect of which have been granted either a valid residents' permit, a valid business permit or a valid visitors' permit may be left without time limit, between the hours of 1 pm and 3 pm on Mon-Fri inclusive.

Existing disabled persons' parking places and an existing trial 'e-scooter & cycle hire' bay in Burchell Road will not be affected by the proposals.

Single yellow lines ('timed' waiting restrictions) will be introduced in Wood's Road covering the full length at each location of existing School Keep Clear markings in the vicinity of John Donne Primary School operating between the hours of 1 pm and 3 pm on Monday to Friday inclusive.

Double yellow lines ('at any time' waiting restrictions) will be introduced throughout the CPZ at road junctions, footway and vehicle crossovers, and between kerbside designated as parking places (in so

much as is public highway), apart from where there are existing School Keep Clear markings. Loading or unloading to or from attended vehicles would be permitted for a maximum of 40 minutes at any single location on double yellow lines.

The Council will take this opportunity to extend existing double yellow lines at key junctions for added junction protection in the roads outside the new CPZ 'QR' in the surrounding area in: Asylum Road, Hollydale Road and Lugard Road. The Council will also take the opportunity to formally amend some measures within the Traffic Management Orders to more closely reflect what is in the street – there will be no physical changes at the following locations made, in order to (i) remove an existing 'doctor only' parking place in Wood's Road which is no longer needed, (ii) add an existing disabled persons' parking place 6.6 metres in length south-west side o/s No. 24 Wood's Road, (iii) relocate an existing cycle hangar from the carriageway to the footway o/s No. 101 King's Grove and (iv) add 6.5 metres existing double yellow lines o/s No. 97 King's Grove.

  - (b) where there is an existing item at a location shown in the map-based schedule attached to the Order of 2021, there were substituted in that map-based schedule the item shown in the map-based schedule attached to this Order.
- 4.2 The amendment or substitution referred to in Article 4.1 (b) of this Order of an item in the mapbased schedule will have the effect of revoking any provision provided or designated by a previous version of that item in the map-based schedule and not incorporated into the latest version.

### Designation of parking place and application of the Order of 2021

- 5.1 Each area on a street identified the map-based schedule as a parking place and, where applicable, by way of the map schedule legend as an area marked out and signed for the use therein of specified classes of vehicles following the conditions specified in the Order of 2021 in relation to that type of parking place, is designated as a parking place.
- 5.2 Unless otherwise so identified, a parking place shall be bounded on one side of its length by the edge of the carriageway and be an area marked either by a traffic sign or by another method of indicating the extent of a parking place as specified in the Traffic Signs Regulations and General Directions 2016°.
- 5.3 The provisions of the Order of 2021 (other than Articles 4 and 19) shall apply to the area designated as a parking place by this Order as if in those provisions any reference to a parking place included a reference to an area designated as a parking place by this Order.

### Placing of traffic signs, etc

- 6.1 The Council must:
  - (a) place and maintain traffic signs or other appropriate markings on the surface of the street indicating the limits of the parking place designated by this Order;
  - (b) place and maintain in or in the vicinity of each parking place, traffic signs indicating that such parking place may be used during the permitted hours for the leaving only of the vehicles specified in Articles 5.1, 5.2, and 5.3 of the Order of 2021;
  - (c) place and maintain in or in the vicinity of each shared-use permit holders and pay parking place a traffic sign indicating that such parking place may be used by vehicles making payment of the parking charge by way of the electronic payment system; and the location identification number of such parking place or part thereof; and
  - (d) carry out work as is reasonably required for the purpose of the satisfactory operation of a parking place.

- 4.1 Each area on a street identified the map-based schedule as either a loading place or parking place by way of the map schedule legend as an area marked out and signed for the use therein of specified classes of vehicles following the conditions specified in the Order of 2021 in relation to that type of loading place or parking place is designated as a loading place or a parking place, as the case may be.
- 4.2 Unless otherwise identified, a loading place or a parking place shall be bounded on one side of its length by the edge of the carriageway and be an area marked either by a traffic sign or by another method of indicating the extent of a loading place or a parking place as specified in the Traffic Signs Regulations and General Directions 2016<sup>c</sup>.
- 4.3 The provisions of the Order of 2021 (other than Articles 4 and 15) shall apply to the area designated as a loading place or a parking place by this Order as if in those provisions any reference to a loading place or a parking place included a reference to an area designated as a loading place or a parking place by this Order.

### Placing of traffic signs, etc

- 5.1 The Council must:
  - (a) place and maintain traffic signs indicating the limits of each parking place and each loading place;
  - (b) place and maintain, in or in the vicinity of each parking place and each loading place, traffic signs indicating that such parking place or loading place, as the case may be may be, used during the permitted hours for the leaving only of the vehicles specified in Article 5.1 of the Order of 2021; and
  - (c) carry out work as is reasonably required for the purposes of the satisfactory operation of a parking place or loading place.

### Waiting and loading restrictions applicable in restricted streets

6.1 Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 2021 shall have effect as though any loading restriction or waiting restriction identified in the map-based schedule and by way of the map schedule legend and marked out and signed as a loading restriction or waiting restriction shall be construed as through it were a restricted street referred to in the Order of 2021.

#### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order, adds or substitutes items in the map-based schedule attached to the Order of 2021, so as to:-

- (a) (i) introduce new and amend existing 'at any time' waiting restrictions (double yellow lines 'DYLs') in so much as is public highway (apart from where there are existing School Keep Clear markings) at road junctions, footway and vehicle crossovers, and between kerbside designated as parking places in Burchell Road, Carlton Grove, King's Grove, Montpelier Road, and Wood's Road; and (ii) to introduce 'timed' waiting restrictions (single yellow lines 'SYLs') operating between the hours of 1 pm and 3 pm on Monday to Friday inclusive in Wood's Road covering the full length at each location of existing School Keep Clear markings in the vicinity of John Donne Primary School (a total of 121 metres), so as to accommodate the provision of the new controlled parking zone 'QR' in the Queen's Road area; and
- (b) the Council will take the opportunity to increase existing 'DYLs' in the roads outside the new Controlled Parking Zone 'QR' in the surrounding area in: (i) Asylum Road east side add 1.5 metres north-west of its junction with Staveley Close and 2.5 metres north of its junction with Station Passage, (ii) Hollydale Road north-east side add 13.5 metres outside Nos. 2 and 4 Hollydale Road and south-west side add 4 metres south of its junction with Lugard Road, and (iii) Lugard Road south-east side add 2.5 metres outside No. 11 Lugard Road; and
- (c) the Council will also take the opportunity, to formally amend some measures within the Traffic Management Order to more closely reflect what is in the street there will be no physical changes at the following locations made, in order to (i) remove an existing 'doctor only' parking place in Wood's Road which is no longer needed, (ii) add an existing disabled persons' parking place 6.6 metres in length in Wood's Road south-west side outside No. 24 Wood's Road, (iii) relocate an existing cycle hangar in King's Grove from the carriageway east side opposite No. 99 King's Grove to a location on the footway opposite No. 101 King's Grove, and (iv) add 6.5 metres existing DYLs in King's Grove outside No. 97 King's Grove,

in the London Borough of Southwark.
