BACKGROUND

- 1. This is an application for dispensation from consultation. The matter has a lengthy procedural history involving numerous sets of directions.
- 2. The matter was listed for a hearing on 5th March 2024. That hearing took place but following an application the Tribunal who sat on that hearing recused itself by a decision dated 15th May 2024.
- 3. As a result of that decision the matter has been transferred to the Southern Region for the purpose of case management.
- 4. I understand a final hearing bundle has been prepared and the matter is ready for hearing. I have reviewed the bundle and I am satisfied that this matter requires a face to face hearing. I believe that a time estimate of 2 days is required. The hearing will take place at a venue in London.
