The Lewisham (Charged-For Parking Places) (Amendment No. *) Order 202*

- Southwark Council hereby GIVES NOTICE that it proposes to make the above Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ('the 1984 Act'), pursuant to arrangements made with the Council of the London Borough of Lewisham under section 9EA of the Local Government Act 2000, in accordance with regulation 7 of the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2012.
- The effect of the Orders would be to introduce new 'at any time' waiting restrictions (double yellow lines) in the following lengths of Sydenham Hill:-Notes: (1) 'at any time' means operating at all hours on every day of the week. (2) All measurements are in metres and are approximate.

(a) on the north and north-west side (which lies in the London Borough of Southwark):-

- (i) at the entrance to Beltwood House (a total of 10 metres, 5 metres on each side);
- (ii) at the entrance to Countisbury House (a total of 20 metres, 10 metres on each side); and
- (iii) at the junction with Wavel Place (a total of 7.4 metres, 3.7 metres on each side);
- (b) on the south and south-east side (which lies in the London Borough of Lewisham):-
 - (i) at the southern junction with Mountacre Close (a total of 8 metres, 4 metres on each side);
 - (ii) at the northern junction with Mountacre Close (a total of 9 metres, 4.5 metres on each side);
 - (iii) at the junction with Tunbridge Court (a total of 10 metres, 5 metres on each side);
 - (iv) at the junction with Droitwich Close (a total of 10 metres, 5 metres on each side);
 - (v) at the entrance to Cissbury House (a total of 12 metres, 6 metres on each side);
 - (vi) at the entrance to the Cuddy Bear Day Care Nursery on the Sydenham Hill Estate (a total of 14 metres, 7 metres on each side); and
 - (vii) at the entrance to Eddisbury House (a total of 14 metres, 7 metres on each side)).

Sydenham Hill 'at any time' waiting restrictions

The London Borough of Southwark (Waiting restrictions) (Sydenham Hill) Order 202* The Lewisham (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Amendment No. **) Order 202* The Lewisham (Charged-For Parking Places) (Amendment No. *) Order 202*

Southwark Council, with the agreement of Lewisham Council, proposes to introduce a prohibition on waiting by vehicles 'at any time' (double yellow lines) on both sides of Sydenham Hill. The north and north-west side of Sydenham Hill lies within the London Borough of Southwark (in the Dulwich Wood ward), and the south and south-east side of Sydenham Hill lies within the London Borough of Lewisham (in the Forest Hill ward and the Sydenham ward).

The overall objectives of this scheme are to prevent obstructive parking to improve sightlines for vehicle drivers and pedestrians alike, thereby improving safety for all.

The new 'at any time' waiting restrictions (double yellow lines) will operate at all hours on every day of the week.

Citation and commencement

1.1 This Order may be cited as the London Borough of Southwark (Waiting restrictions) (Sydenham Hill) Order 2024 and comes into force on xx xxxxxx 202*.

Interpretation

2.1 In this Order:-

"this Order" means the London Borough of Southwark (Waiting restrictions) (Sydenham Hill) Order 202*;

"the Order of 2021" means the London Borough of Southwark (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Map-based) Order 2021^b;

"Council" means the Council of the London Borough of Southwark;

"enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

"map-based schedule" means the map attached to and to be read in conjunction with this Order and the Order of 2021, which shows the restrictions imposed by this Order and, in conjunction with the map schedule legend, identifies the waiting restriction and, if appropriate, certain of its governing provisions:

Provided that the Council does not accept responsibility for any inaccuracies contained in the Ordnance Survey data relied upon to create the map-based schedule, and where a restriction is shown on the map-based schedule, that restriction will continue to apply irrespective of any subsequent changes that have been made to the Ordnance Survey data.

"map schedule legend" means the map schedule legend attached to this Order which, when used in conjunction with the map-based schedule, identifies the waiting restrictions imposed by this Order and, where appropriate, certain of their governing provisions; and

"traffic sign" means a sign of any size, type and colour prescribed or authorised under, or having effect as though prescribed or authorised under, section 64 of the Road Traffic Regulation Act 1984.

- 2.2 Any reference in this Order to any enactment must be read as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 2.3 Any expression used in this Order which is also used in the Order of 2021 must have the same meaning as in the Order of 2021, unless stated otherwise.

Amendment of items in the map-based schedule

- 3.1 While this Order remains in force, and without prejudice to the validity of anything done, or to any liability incurred in respect of any act or omission before the coming into force of this Order, the Order of 2021 must have effect as though:-
 - (a) where there is no existing item at a location shown in the map-based schedule attached to the Order of 2021, there were added to that map-based schedule the item shown in the map-based schedule attached to this Order; and
 - (b) where there is an existing item at a location shown in the map-based schedule attached to the Order of 2021, there were substituted in that map-based schedule the item shown in the map-based schedule attached to this Order.
- 3.2 The amendment referred to in Article 3.1(b) of this Order of any item in the map-based schedule will have the effect of revoking any provision provided or designated by a previous version of that item in the map-based schedule and not incorporated into the latest version.

Waiting restrictions applicable in restricted streets

4.1 Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 2021 shall have effect as though any waiting restriction identified in the map-based schedule and by way of the map schedule legend and marked out as a waiting restriction shall be construed as through it were a restricted street referred to in the Order of 2021.

"the Order of 2017" means The Lewisham (Charged-For Parking Places) Consolidation Order 2017^b.
