- 1. Southwark Council hereby GIVES NOTICE that it proposes to make the above Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of the Orders, within Controlled Parking Zone ('CPZ') 'T' in the vicinity of the new Burgess Park Sports Centre, the purpose of which would be to facilitate the priorities of the area and the centre, would be to:-
- (a) remove existing 'shared-use' (CPZ 'T' permit-holders and pay by phone parking only) parking and add new lengths of 'at any time' waiting restrictions (double yellow lines 'DYLs') to accommodate the parking changes (in both roads mentioned below) and add new Disabled Persons' parking places (in Cobourg Road):- (i) in COBOURG ROAD outside and opposite the Burgess Park Sports Centre a total of 128.5 metres removed (92 metres on the north-west side of which 15.6 metres remain, and 36.5 metres on the south-east side of which 20.5 metres remain) and replaced with a total of 116.5 metres of 'DYLs' and 2 new 'unlimited stay' Disabled Persons' parking places on the north-west side (operating 'at any time' and without time limit each 6 metres in length), and (ii) in LONCROFT ROAD north-west of its junction with Cobourg Road a total of 22.5 metres removed (11.5 metres on the north-east side of which 7 metres remain, and 11 metres on the south-west side of which 29 metres remain) and replaced a total of 22.5 metres of 'DYLs'; and
- (b) in COBOURG ROAD extend existing 'shared-use' parking outside and opposite the Burgess Park Sports Centre and remove existing 'DYLs' to accommodate (i) north-west side by 2 metres (new bay will be 15.6 metres in length) and remove 2 metres existing DYLs, and (ii) south-east side by 15.5 metres (new bay will be 52 metres in length) and remove 5 metres of existing 'DYLs'. NOTES: (1) 'at any time' means at all hours on every day of the week. (2) Disabled Persons' parking places may only be used by vehicles displaying a valid Disabled Persons' 'blue badge'. (3) All measurements are in metres and are approximate. (4) Parking charges are listed on www.southwark.gov.uk/parking
- 3. Southwark Council hereby GIVES FURTHER NOTICE under sections 90A to 90I of the Highways Act 1980 and in accordance with the provisions of the Highways (Traffic calming) Regulations 1999, propose to construct speed tables of flat-top construction having a maximum height level with the surrounding kerb covering the entire width of the carriageway, at the following locations:
- (a) at the COBOURG ROAD and LONCROFT ROAD junction extending from a point 0.5 metres north-east of the common boundary of Nos. 102 and 104 Cobourg Road south-westward for a distance of 23.2 metres, and extending into LONCROFT ROAD from its junction with Cobourg Road north-westward for a distance of 8.5 metres; and
- (b) in COBOURG ROAD extending from a point 44 metres south-west of the south-western kerb-line of Loncroft Road south-westward for a distance of 7 metres. The measurements above include the ramps, and any existing traffic calming measures at the exact locations above will be refreshed and replaced.

The London Borough of Southwark (Charged-for parking places) (Cobourg Road area improvements) Order 202*

The London Borough of Southwark (Free Parking Places and Waiting restrictions) (Cobourg Road area improvements) Order 202*

The scheme proposes changes in the Cobourg Road area in the vicinity of the Burgess Park Sports Centre (within the Faraday ward and the Old Kent Road ward), in the London Borough of Southwark.

The purpose of the changes is to facilitate the priorities of the area for the new development: Burgess Park Sports Centre, and to accommodate new accessible parking and to promote walking and cycling to the centre. A total of 128.5 metres of existing 'shared-use' parking (CPZ 'T' permit-holders and pay by phone parking only) in Cobourg Road and a total of 22.5 metres of existing 'shared-use' parking in Loncroft Road will be removed, and replaced with new lengths of 'at any time' waiting restrictions (double yellow lines 'DYLs') to accommodate the parking changes (in both roads mentioned above) and to add new 'unlimited stay' Disabled Persons' parking places (in Cobourg Road). There will be an additional 17.5 metres in total of 'shared-use' parking added to Cobourg Road, by way of removing existing 'DYLs' and shifting the existing parking bay lines.

There will be new traffic calming measures introduced, in the form of raised speed tables, at the Cobourg Road and Loncroft Road junction and at another location in Cobourg Road to reduce motor traffic speeds at designated pedestrian crossing points in the vicinity of the Burgess Park Sports Centre.

The developer was granted planning permission (ref: 21/AP1002) for this project to make changes to the road marking layout to support the Burgess Park Sports Centre.

Citation and commencement

1.1 This Order may be cited as the London Borough of Southwark (Charged-for parking places) (Cobourg Road area improvements) Order 202* and comes into force on xx xxxxxxxxx 202*.

Interpretation

2.1 In this Order:-

"this Order" means the London Borough of Southwark (Charged-for parking places) (Cobourg Road area improvements) Order 202*;

"the Order of 2021" means the London Borough of Southwark (Charged-For Parking Places) (Map-based) Order 2021^b;

"Council" means the Council of the London Borough of Southwark;

"enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

"map-based schedule" means the map attached to and to be read in conjunction with this Order and the Order of 2021, which shows the parking place amended by this Order, and, in conjunction with the map schedule legend, identifies the type of each particular parking place and, if appropriate, certain of its governing provisions:

Provided that the Council does not accept responsibility for any inaccuracies contained in the Ordnance Survey data relied upon to create the map-based schedule and where a parking place is shown on the map-based schedule, that parking place will continue to apply irrespective of any subsequent changes that have been made to the Ordnance Survey data.

"map schedule legend" means the map schedule legend attached to this Order which, when used in conjunction with the map-based schedule, identifies the specific type of parking place amended by this Order and, where appropriate, certain of its governing provisions; and

"traffic sign" means a sign of any size, type and colour prescribed or authorised under, or having effect as though prescribed or authorised under, section 64 of the Road Traffic Regulation Act 1984.

- 2.2 Any reference in this Order to any enactment must be read as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 2.3 Any expression used in this Order which is also used in the Order of 2021 must have the same meaning as in the Order of 2021, unless stated otherwise.

Addition to or substitution of items in the map-based schedule

- 3.1 Without prejudice to the validity of anything done, or to any liability incurred in respect of any act or omission before the coming into force of this Order, the Order of 2021 must have effect as though:-
 - (a) where there is no existing item at a location shown in the map-based schedule attached to the Order of 2021, there were added to that map-based schedule the item shown in the map-based schedule attached to this Order; and
 - (b) where there is an existing item at a location shown in the map-based schedule attached to the Order of 2021, there were substituted in that map-based schedule the item shown in the map-based schedule attached to this Order.
- 3.2 The amendment or substitution referred to in Article 3.1(b) of this Order of an item in the mapbased schedule will have the effect of revoking any provision provided or designated by a previous version of that item in the map-based schedule and not incorporated into the latest version.

Designation of parking place and application of the Order of 2021

- 4.1 Each area on a street identified in the map-based schedule as a parking place and, where applicable, by way of the map schedule legend, as an area marked out and signed for the use of specified classes of vehicles following the conditions specified in the Order of 2021 in relation to that type of parking place, is designated as a parking place.
- 4.2 Unless otherwise so identified, a parking place must be bounded on one side of its length by the edge of the carriageway and be an area marked either by a traffic sign or by another method of indicating the extent of a parking place, as specified in the Traffic Signs Regulations and General Directions 2016°.
- 4.3 The Order of 2021 (other than Articles 4 and 19) applies to the areas designated as a parking place by this Order, as if in the provisions of the Order of 2021, any reference to a parking place included a reference to an area designated as a parking place by this Order.

Placing of traffic signs, etc

- 5.1 The Council must:
 - (a) place and maintain traffic signs or other appropriate markings on the surface of the street indicating the limits of the parking place designated by this Order;
 - (b) place and maintain in or in the vicinity of each parking place, traffic signs indicating that such parking place may be used during the permitted hours for the leaving only of the vehicles specified in Articles 5.1, and 5.3 of the Order of 2021;
 - (c) place and maintain in or in the vicinity of each shared-use (permit holders and pay) parking place a traffic sign indicating that such parking place may be used by vehicles making payment of the parking charge by way of the electronic payment system; and the location identification number of such parking place; and

(d) carry out work as is reasonably required for the purpose of the satisfactory operation of a parking place.

"map-based schedule" means the map attached to and to be read in conjunction with this Order and the Order of 2021, which shows the parking places designated by this Order, and the waiting, restrictions imposed by this Order, and, in conjunction with the map schedule legend, identifies the type of each particular parking place, or waiting restriction and, if appropriate, certain of its governing provisions:

Provided that the Council does not accept responsibility for any inaccuracies contained in the Ordnance Survey data relied upon to create the map-based schedule and where a parking place, loading place or waiting, loading or stopping restriction is shown on the map-based schedule, that parking place, loading place or waiting, loading or stopping restriction will continue to apply irrespective of any subsequent changes that have been made to the Ordnance Survey data.

- 3.2 The amendment referred to in Article 3.1 of this Order of an item in the map-based schedule will have the effect of revoking any provision provided or designated by a previous version of that item in the map-based schedule and not incorporated into the latest version.

Designation of parking places and application of the Order of 2021

- 4.1 Each area on a street identified the map-based schedule as a parking place by way of the map schedule legend as an area marked out and signed for the use therein of specified classes of vehicles following the conditions specified in the Order of 2021 in relation to that type of parking place is designated as a parking place.
- 4.2 Unless otherwise so identified, a parking place must be bounded on one side of its length by the edge of the carriageway and be an area marked either by a traffic sign or by another method of indicating the extent of a parking place as specified in the Traffic Signs Regulations and General Directions 2016^c.
- 4.3 The provisions of the Order of 2021 (other than Articles 4 and 15) applies to the areas designated as a parking place by this Order, as if in the provisions of the Order of 2021, any reference to a parking place included a reference to an area designated as a parking place by this Order.

Placing of traffic signs, etc

- 5.1 The Council must:
 - (a) place and maintain traffic signs indicating the limits of each parking place;
 - (b) place and maintain, in or in the vicinity of each parking place, traffic signs indicating that such parking place used during the permitted hours for the leaving only of the vehicles specified in Article 5.1 of the Order of 2021; and
 - (c) carry out work as is reasonably required for the purposes of the satisfactory operation of a parking place.

Waiting restrictions applicable in restricted streets

6.1 Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 2021 must have effect as though any waiting restriction identified in the map-based schedule and by way of the map schedule legend and marked out as a waiting restriction must be construed as through it were a restricted street referred to in the Order of 2021.

(This note is not part of the Order)

This Order, adds or substitutes items in the map-based schedule attached to the Order of 2021, so as to accommodate changes in the vicinity of the Burgess Park Sports Centre, to:-

- (a) add new lengths of 'at any time' waiting restrictions (double yellow lines 'DYLs') to accommodate the parking changes in Cobourg Road (a total of 116.5 metres) and Loncroft Road (a total of 22.5 metres);
- (b) remove a total of 17.5 metres existing DYLs in Cobourg Road to accommodate parking changes;and
- (c) add 2 new 'unlimited stay' Disabled Persons' parking places (each 6 metres in length) in Cobourg Road north-west side,
