

## STREET WORKS PERMIT APPLICATION FORM

SECTION 50 OF THE NEW ROADS AND STREET WORKS ACT 1991 &

LONDON PERMIT SCHEME

## GRANTED TO OWNERS OF PROPERTY WISHING TO PLACE, MAINTAIN OR RETAIN APPARATUS IN THE PUBLIC HIGHWAY

#### NOTE:

- 1. ANY WORKS UNDERTAKEN ON THE PUBLIC HIGHWAY <u>MUST</u> BE CARRIED OUT BY NEW ROADS AND STREET WORKS ACT 1991 (NRSWA) ACCREDITED OPERATIVES AND SUPERVISED BY AN NRSWA ACCREDITED SUPERVISOR
- 2. NOTICE PROCEDURES MUST BE STRICTLY ADHERED TO. SECTION 74 OF THE NEW ROADS AND STREET WORKS ACT 1991 APPLIES IN THE LONDON BOROUGH OF SOUTHWARK

### NOTES OF GUIDANCE FOR PERSONS WISHING TO CARRY OUT STREET WORKS

#### New Roads and Street Works Act 1991 (London Permit Scheme) - Section 50

Anyone other than a Statutory Undertaker wishing to carry out street works which includes the breaking open, boring or tunneling under any street to place, adjust, repair, alter or renew any apparatus **MUST BE IN POSSESSION OF A STREET WORKS LICENCE,** which has been granted to the **OWNER** of the property that the apparatus serves or the principal contactor (developer) employing a 3<sup>rd</sup> party contractor to undertake the works.

The Licence allows the, placing and/or the retention of the apparatus in the street and thereafter the right to adjust, repair, alter or renew it, so long as the conditions as laid down by the Act and its associated codes of practice are complied with. The apparatus must be kept in good condition and must also comply with any conditions with regard to safety, inconvenience to persons, in particular the disabled, using that street, and the structure of the street, that the Council may impose.

**THE LICENCE HOLDER** will be the owner of the plant/apparatus and will be responsible for every aspect of the licence including: -

- (i) Proof of Public Liability Insurance Minimum cover of £5 million.
- (ii) Charges £5,738.80 including administration & all inspection fees (£738.80), a refundable bond (£5000:00) against defects during the 2 year period of guarantee or proof that a performance bond has been taken. Please see notes
- (iii) Reinstatements as per the Codes of Practice.
- (iv) Notice procedures (works) as per the Codes of Practice.
- (v) Removal of waste as per the Waste Removal Regulations.

The New Roads and Street Works Act and associated codes of practice are available from H.M.S.O.

If assignment of the Licence is required, consent of the Street Authority must be obtained.

#### Doing the work

The Licence holder must ensure that all works are supervised and completed by NRSWA accredited operatives. The Licence holder will remain responsible for every aspect of the works, and <u>MUST</u> notify the London Borough of Southwark as to when the work will start and finish in accordance with the procedures laid down by the NRSWA Codes of Practice.

Within a S.50 Licence, works may be undertaken on multiple streets or straddle two streets. While only one licence fee will be charged, individual permits will be required for each street and therefore, additional permit fees will be applied to the licence fee. These additional fees are detailed below.

**WARNING**: Where the Highway Authority believes works are unreasonably delayed or there is unreasonably prolonged occupation of the Highway, Section 74 of The New Roads and Street Works Act 1991 will be applied. (See Table 1-S.74 Charges and Table 2-Notification Periods)

#### **Obtaining the Licence**

The following documentation *must* be submitted in support of your application:

- A traffic management plan detailing the location of the proposed works and proposed traffic management.
- Method Statement
- Thames Water Connection Consent (only applicable if works are for connection to a public sewer)
- Safety Policy
- Proof of public & third party liability
- Proof of operatives/supervisors NRSWA accreditation
- Full payment, including Performance Bond \*

#### No applications will be considered without all of the above documentation.

#### **IMPORTANT NOTICE**

THE STREETWORKS (CHARGES FOR UNREASONABLY PROLONGED OCCUPATION OF THE HIGHWAY) REGULATIONS 2001.

Section 74 of the New Roads and Street Works Act 1991 is applied in the London Borough of Southwark.

Where a Street Works Licence holder does not give the proper notices of starting and ending their works they will be subject to the following charges.

Works that continue beyond the agreed duration in the Permit Application will be liable to the following charges:

#### i) FOR STARTING THE WORK

When you wish to start the work you **MUST** forward the Notice marked 'Part N' to this office and comply with the notice periods that applies to your circumstances. This notice **MUST** be fully completed.

• Note: Immediate Works are deemed In this Part "emergency works" means works whose execution at the time when they are executed is required in order to put an end to, or to prevent the occurrence of, circumstances then existing or imminent (or which the person responsible for the works believes on reasonable grounds to be existing or imminent) which are likely to cause danger to persons or property.

#### INTERIM REINSTATEMENT

All temporary reinstatements **MUST** perform to the same standards as permanent reinstatements as set out in the Specification of Reinstatement and Openings in the Highway (SROH) and **MUST NOT** remain temporary for longer than **six months** without special dispensation from the local authority.

#### ii) PERMANENT REINSTATEMENT

Once the reinstatement has been made permanent, you **MUST** complete notice **'Part R1P'** and return it this office **before 7 days have elapsed.** 

You are required to guarantee the works for two years, or three years if the works are more than 1.5 metres deep. The guarantee does not begin until the permanent reinstatement has been completed.

Failure to return the forms WILL extend your guarantee period and may incur charges under Section 74 of the New Roads and Street Works Act 1991.

You are required to have Third Party & Public Liability insurance cover for the apparatus, and to indemnify the Council against any claims arising from consent to place and retain plant or apparatus in a public highway.
